

General Terms and Terms of Payment

The following Terms are valid from January 4th 2010.

The information posted on this website is compiled by Reykjavik Marathon and are not by any means guaranteed to be accurate or exhaustive. The information may furthermore be imperfect, i.e. they may include aberrations, faults and etc., and may be out-of-date. Therefore it would be prudent to verify the information at the offices of Reykjavik Marathon before any arrangements are made that is based on them.

I. GENERAL TERMS

1. The following Terms apply to the payment of the entry fee from the participant to Reykjavik Marathon. By signing up, and paying an entry-fee for an event held by Reykjavik Marathon, the participant agrees to defer to the Terms.
2. Reykjavik Marathon is not responsible for the health of participants in any of its events, neither during nor after.
3. It is admissible for Reykjavik Marathon to update or alter these Terms at any time without any notice of any kind. By agreeing to defer to these Terms the participant accepts to be bound by any changes.
4. The participant agrees to give Reykjavik Marathon full and unrestricted access, without any compensation, to all his personal information sent to Reykjavik Marathon via the registration website, under the notice that those information are to be used for marketing research and etc. Note that the information will only be used by Reykjavik Marathon and will never be distributed to a third party.
5. Runners who do not wish to receive e-mail messages from Reykjavik Marathon regarding Reykjavik Marathon races and related running activities can choose that in the registration process. They should though keep in mind that they might miss out on some useful information.
6. All trade names, brands, logos and etc that are posted on the Reykjavik Marathon website are protected by Icelandic and international law. Any use of any such object is prohibited without the prior written approval by Reykjavik Marathon.
7. Reykjavik Marathon does not guarantee the contents of any websites which may be linked to the Reykjavik Marathon website. Reykjavik Marathon does not have any say over topics, subjects or the setup of any websites other than its own.

II. TERMS OF PAYMENT

8. On the registration website there is a calculator which will provide the participant with the entry fee he will be asked to pay. The entry fee will be provided in Euros. If a participant is to pay for multiple participants the calculator will reveal the total entry fee.
9. No taxes will be added to the provided entry fee.
10. Registration fee for Reykjavik Marathon Íslandsbanka, Lazy Town Run and Midnight Run cannot be refunded. Entry fee for Laugavegur Ultra Marathon can be partly refunded latest three weeks before the race day.
11. If the Reykjavik Marathon Íslandsbanka, LazyTown Run, the Midnight Run and the Laugavegur Ultra Marathon do not go ahead as planned, due to natural catastrophes, adverse weather conditions etc., the entry fee will not be repaid.
12. Registration for an event is not possible without the previous payment of the required entry fees.
